Fall 2022 Interpreter Training and Employment Recruitment Notice

Language Access, a **Shared Health** service, employs professional, trained interpreters (casual employees) scheduled on an as-needed basis to work with service providers and limited/non-English speakers in various healthcare and non-healthcare settings. These include hospitals, health clinics, private residences, personal care homes, as well as a variety of other settings such as schools and provincial courts.

QUALIFICATIONS

- Demonstrated fluency in English and in target language.
- Demonstrated interpreter skills
- High school diploma or equivalent
- Flexible schedule with **daytime** availability
- Ability to access and use information technology effectively (Internet/E-mail/Virtual meeting platforms)

ASSETS

- Strong interpersonal, organizational and problem-solving skills
- Ability to work in stressful and sensitive situations with limited supervision
- Prior interpreting experience, preferably in healthcare/social services
- Knowledge of medical terminology, health reference and resources
- Commitment to ongoing professional development
- Valid driver's license and access to a vehicle

We are currently seeking individuals who are fluent in English and one or more of the following languages:

Bosnian, French, Fulani, Hausa, High German, Italian, Karen, Kinyarwanda, Kirundi, Kumanji, Nuer, Polish, Punjabi, Rohingya, Sango, Spanish, Tamasheq, Ukrainian

Applications are being accepted for the 12-day
Fall 2022 Virtual Interpreter Training session scheduled for
September-November 2022.

Candidates must complete the following screening steps to be considered for this free professional interpreter training opportunity:

- Telephone interview
- CILISAT Interpreter Skills Assessment
(Testing is coordinated by Language Access. Candidates pay a \$65 administration fee and marking costs are covered by Language Access)
- Personal Interview

Successful completion of the Interpreter Training Program is a condition of employment to be achieved prior to hiring as a casual interpreter with Language Access, Shared Health.

Training seats will only be offered to candidates who are being considered for this employment opportunity.

The Shared Health Interpreter Training is offered to selected participants at no cost with support from the Province of Manitoba. The professional curriculum is delivered by experienced facilitators and was developed based on the Code of Ethics & Standards of Practice for Interpreters. Learners are introduced to the core competencies and professional standards required for interpreters as well as an introduction to medical terminology.

Upon successful completion of the training, individuals may be offered employment (casual) as Interpreters with Language Access, Shared Health. Employment benefits include and are not limited to:

- Four-step salary scale ranging from \$24.21/hr to \$29.25/hr
- Two-hour minimum shift duration for face-to-face assignments & Shift premiums (evening, night, weekend)
- Reimbursement for paid parking
